REQUEST: REVISION TO A PREVOUSLY APPROVED SUBDIVISION (S-22-14) of one

parcel of 1.969 acres into 9 lots zoned Residential-10 (R-10) and within a Neighborhood Conservation Overlay District (the Mordecai Neighborhood-Conservation District 1). All proposed lots front onto Courtland Drive. This subdivision (original Transaction # 401274) was first submitted post September 1, 2013 and is subject to the Unified Development Ordinance. A previously approved revision (Transaction 540505) proposed an extension to

the sunset date established by the original submittal.

This Revision (Transaction # 567323) changes the stormwater

management approach from the original detention device, to an allocation

of impervious surface.

DESIGN ADJUSTMENT(S)/ ALTERNATES, ETC:

A Design Adjustment has been approved by the Public Works Director for this

project, noted below. (original Transaction # 401274)

As per Section 8.3 of UDO, a Design Adjustment from the Public Works Director has been granted waiving the block perimeter requirement (8.3.2). Support is based on the existing railroad line spanning the length of the rear property line, topographic constraints, and no logical terminus of a public street from this

subdivision to Capital Blvd.

FINDINGS: City Administration finds that this request, with the below conditions of approval

being met, conforms to the Unified Development Ordinance. This approval is based on a preliminary plan dated 8/20/2018 by John A. Edwards & Company.
