

SUBDIVISION STANDARDS:							
LOT LAYOUT:	The n an int lot wid feet n	The minimum lot size in the Residential-6 zoning district is 6,000 square feet. The minimum lot depth in this zoning district is 80 feet. The minimum lot width of an interior lot in this zoning district is 50 feet. As these lots front on a cul-de-sac, lot width can be reduced to 20'. However, the required standard lot width of 65 feet must be met at with at least 70 feet of lot depth remaining. Lots in this development conform to these minimum standards.					
PUBLIC UTILITIES:		City water and sewer services are available. The subdivider is responsible for installation of all lines necessary to provide service to this site.					
SOLID WASTE:	Indivi	Individual lot service by the City is to be provided.					

BLOCKS / LOTS / ACCESS:	The block perimeter measurement within this subdivision is based on R-6 zoning and the maximum block length should be 6,000 linear feet. A design adjustment was approved by the Public Works Director eliminating the public street connection requirement to meet the maximum block perimeter.
STREETSCAPE TYPE:	The applicable streetscape is residential. Developer is planting street trees as required by the UDO.
PEDESTRIAN:	No sidewalk is proposed. Developer is paying a fee-in-lieu for sidewalk.
FLOOD HAZARD:	There are no flood hazard areas on this site.
STORMWATER MANAGEMENT:	This site is exempt from stormwater controls under UDO Article 9.2.2.A.1 as this subdivision is less than 1 acre in aggregate size.
WETLANDS	
/ RIPARIAN BUFFERS:	No wetland areas or Neuse River riparian buffers are required on this site.
STREET NAMES:	Three no new streets being proposed with this development.
OTHER REGULATIONS:	Developer shall meet all City requirements, including underground utility service, flood protection measures, and the soil erosion ordinance, unless specifically varied by this approval.

SUNSET DATES: If significant construction has not taken place on a project after preliminary subdivision approval, that approval may "sunset" and be declared void, requiring re-approval before permits may be issued. To avoid allowing this preliminary approval to "sunset", the following must take place by the following dates:

3-Year Sunset Date: 11/10/17 Record entire subdivision.

• MEET ALL CONDITIONS OF APPROVAL.

• <u>COMPLETE CONSTRUCTION DRAWINGS FOR ANY PUBLIC</u> <u>IMPROVEMENTS</u> Streets, Utility lines to be owned and maintained by the City. and submit them to the Development Plans Review Center for approval.

• <u>HAVE A REGISTERED SURVEYOR PREPARE FINAL PLATS FOR</u> <u>RECORDING.</u> These also must be submitted to the Development Plans Review Center for authorization signature prior to recording with the Wake County Register of Deeds.

• <u>MEET THE REQUIREMENTS OF THE SUNSET THRESHOLDS AS NOTED</u> <u>ABOVE.</u>

FACILITY FEES REIMBURSEMENT:

If oversized street construction takes place, or greenway or oversized public street right-of-way is conveyed to the public, the owner is responsible for application to the City for reimbursement allowed by Code. Reimbursement takes place twice a year in January and July; a written request must be filed with the Planning Department for greenway and street right-of-way; and in the Engineering Department for street construction; by the first working day in November and May each year.
