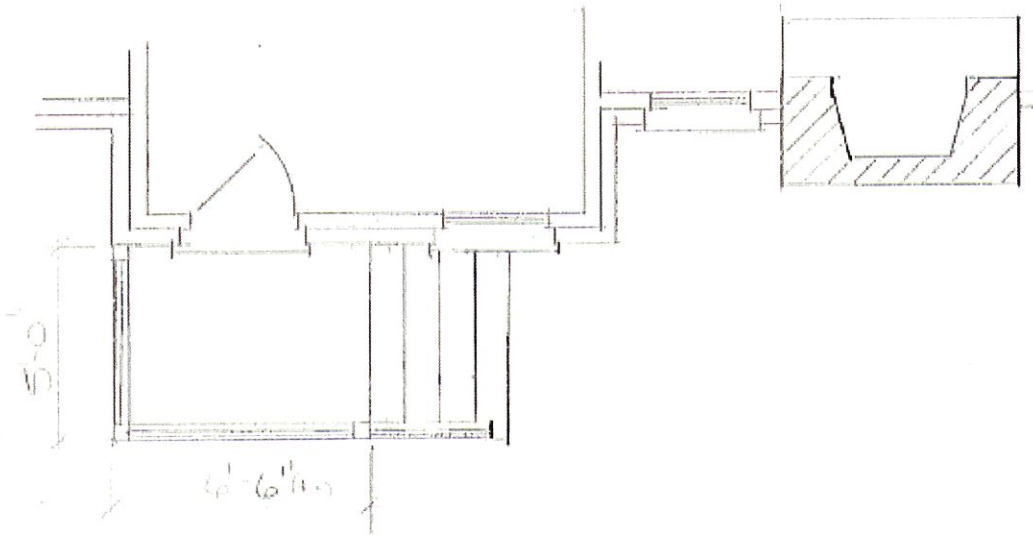

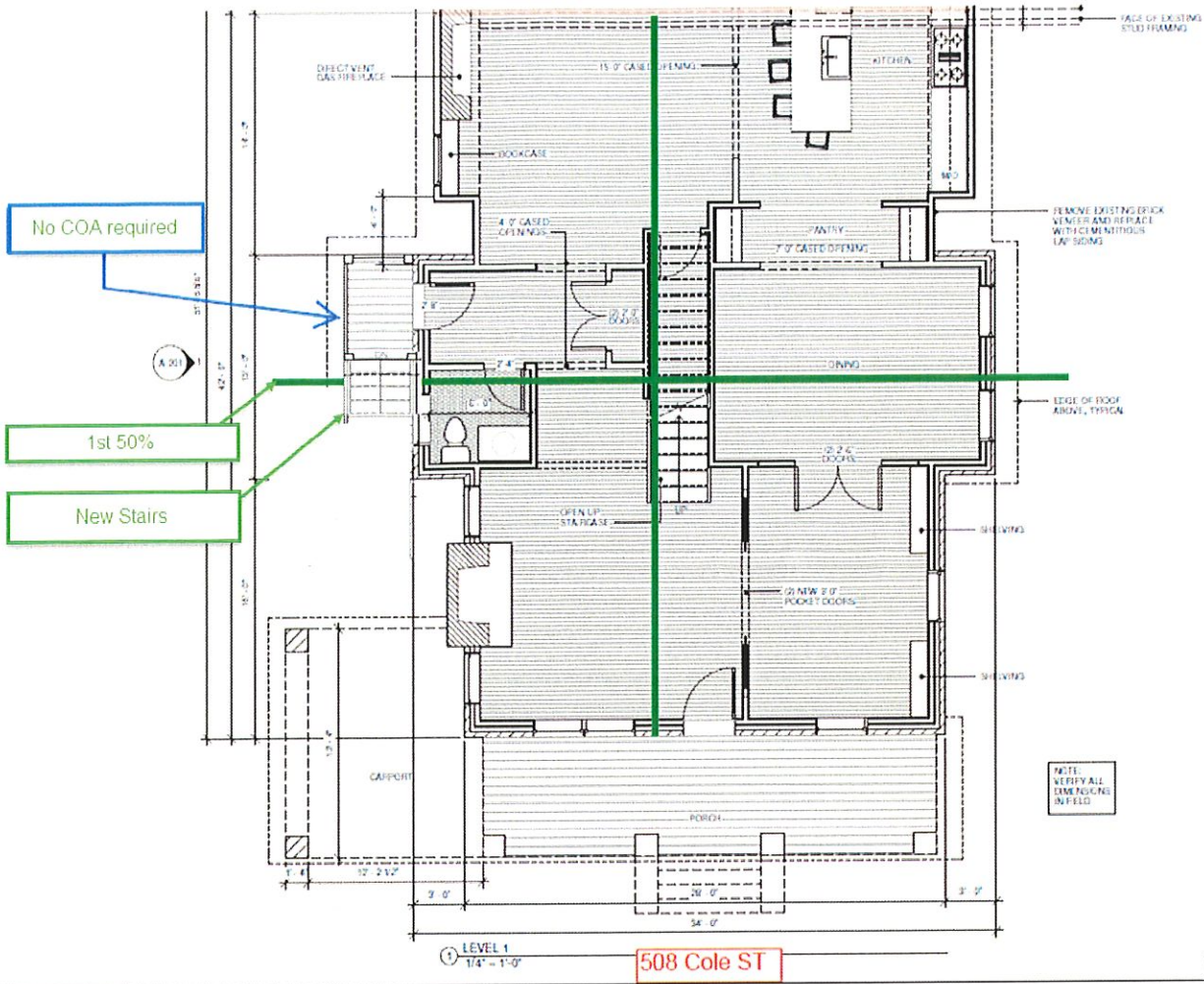
LEFT SIDE PORCH ELEVATION

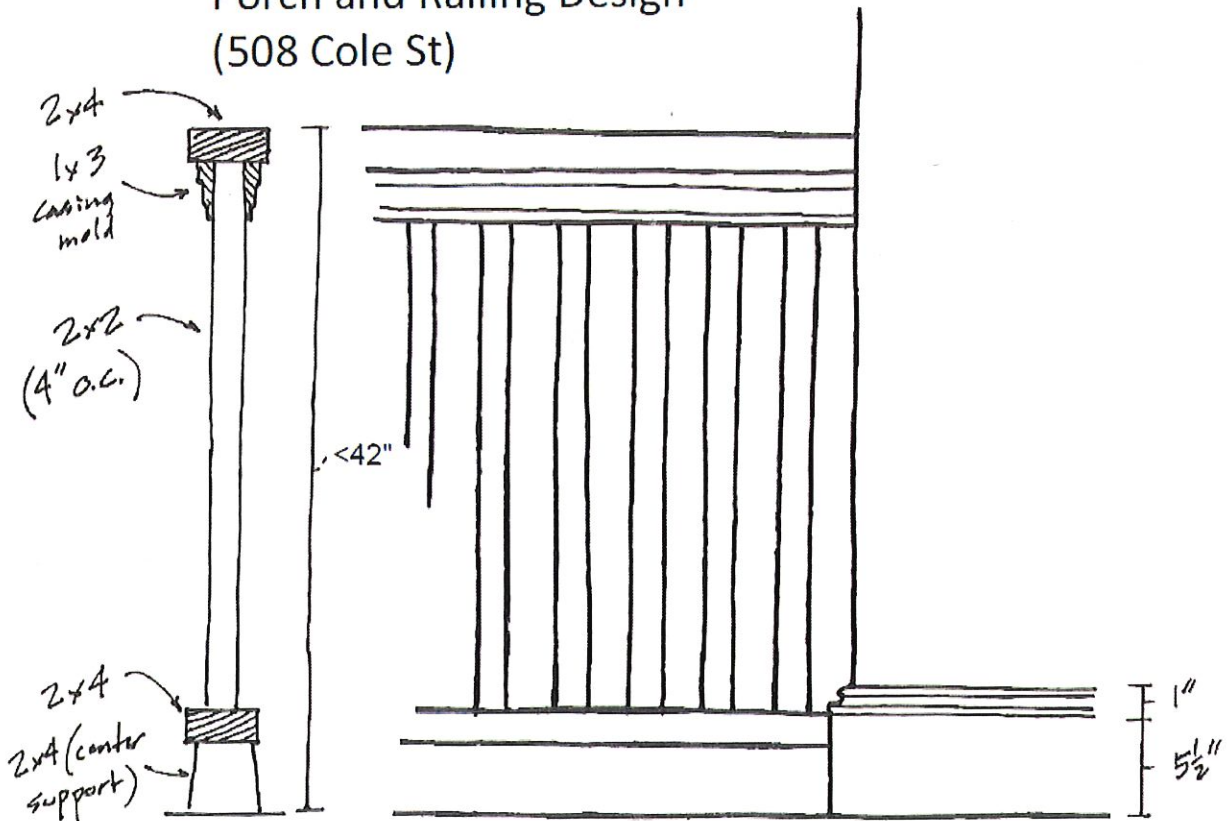
FRONT SIDE PORCH

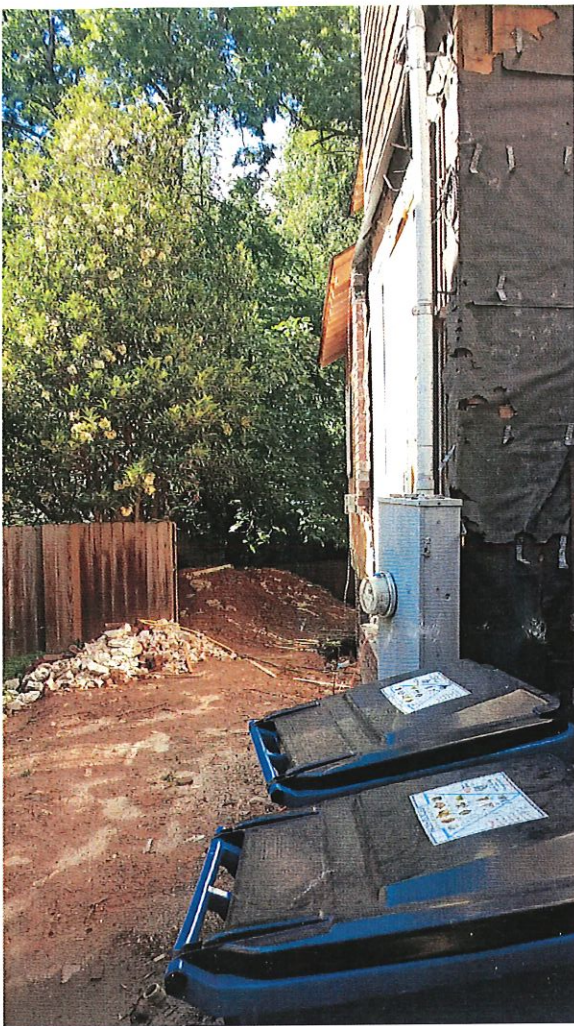


LEFT SIDE PORCH PLAN

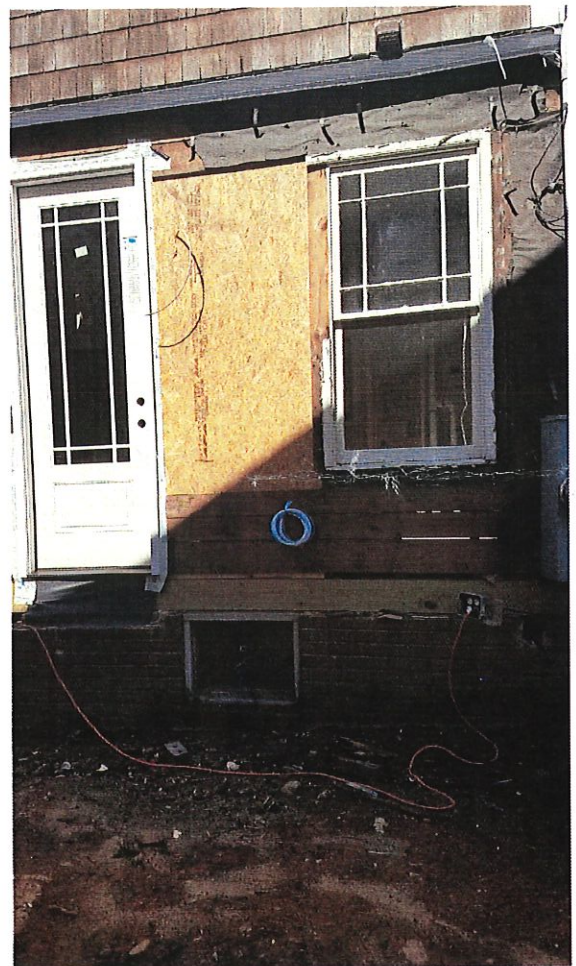
Porch and Railing Design (508 Cole St)
